### Shortcode: factbank

Factbank Title: Aboriginal Allied Health Award

The Aboriginal Allied Health Award is for nominees who identify as an Aboriginal and/or Torres Strait Islander person.

Factbank Content:

The Allied Health Assistant of the Year applies to nominees who have a dedicated Allied Health Assistant role, which may include providing clinical as well as administrative support.

The winner of this category will have demonstrated a commitment to elevating the human experience in health care through their commitment to the allied health service for their organisation.

Factbank Title: Allied Health Team of the Year

Factbank Content:

The Allied Health Team of the Year applies to a team demonstrating an outstanding contribution as a collective team, and to clinical excellence by delivering high performing allied health services and patient and/or service outcomes across any healthcare setting.

The winner of this category will be recognised by their peers, demonstrate outstanding professionalism and actively support a positive and collaborative culture.

Factbank Title: Allied Health Researcher of the Year

Factbank Content:

The Allied Health Researcher of the Year applies to nominees who hold a clinical or clinical leadership role and engages in research activities. Nominees may or may not have protected research time. It is open to novice, early career, and experienced researchers.

The winner of this category will have demonstrated the impact of their research in WA on service and/or patient outcomes and how they are supporting clinicians to implement research in clinical practice as well as build research capacity.

Factbank Title: Allied Health Educator of the Year

Factbank Content:

The Allied Health Educator of the Year applies to nominees who deliver impactful contributions to improve the best practice allied health service delivery through learning and development for Allied Health professionals.

The winner of this category will have demonstrated a significant impact from their contribution to educating Allied Health professional peers, students, other health disciplines, patients, or the general public.

They may hold a conjoint academic appointment in addition to their clinical role, but this is not their primary role. They may be a higher degree by research student who is achieving at a high level and meets the criteria set out below. They contribute to building the capacity of other staff to conduct and translate research in allied health services, for example by supervising research students or clinicians, leading research teams, or mentoring novice researchers.

This Award is open to early and experienced researchers. Applications will be assessed based on the impact of their research in WA and how they are supporting clinicians to implement research in clinical practice as well as build research capacity.
