**2024/25 FOOD ACT 2008 AND PUBLIC HEALTH ACT 2016 LOCAL  
GOVERNMENT REPORTING REQUIREMENTS**

Please be advised that the Department of Health is now collecting information from local government enforcement agencies on the performance of functions under the *Food Act 2008*, as required by Section 121, and the *Public Health Act 2016*, as required by Section 22, for the period 1 July 2024 to 30 June 2025.

To meet your reporting requirements please complete the reporting form online at <https://consultation.health.wa.gov.au/environmental-health-directorate/2024-25-food-act-public-health-act-reporting> by 31 August 2025.

The reporting questions are attached for your reference; however, the report must be submitted online. Authorised officers completing the online report will have to obtain authorisation from the local government's Chief Executive Officer.

**Optional reporting - *Public Health Act 2016***

In addition to the mandatory reporting, the Department of Health is seeking to formalise and refine the collection of operational data as per section 22 of the *Public Health Act 2016* as stage 5 of the implementation begins.

Additional reporting questions are being asked to provide the Department of Health with data from across the state. This data will be compiled in a series of reports to local government to assist with regional comparison of risks and inform public health planning under the *Public Health Act 2016*.
